1. KNOWLEDGE OF THESE REGULATIONS

Every person, body, group of persons, etc., promoting, organizing, or participating in a competition or event, by and upon applying for an agreement, sanction or permit or license of any kind from the SKC shall by doing so be deemed to and recognize that:

- a) They have acquainted themselves with these Regulations.
- b) They have submitted themselves without reservation to the consequences resulting from the application of these regulations.
- c) Have renounced, under pain of disqualification, the right to have recourse to any arbitrator or judicial tribunal not provided for in these Regulations.
- d) Have agreed to exonerate and keep indemnified all bodies; sponsors and their agents, racetrack owners, race organizers and their officials and agents, Sudbury Kart Club Corporation and its directors, officers, officials and its subsidiaries, agents and associate members, from and against all liability whatsoever to any such persons respectively in respect of, or in connection with any meeting, competition, or event held under these Regulations, from whatever cause arising or alleged to arise and notwithstanding that the same may have been contributed to, or occasioned by, the negligence of the said bodies, their agents, officials, servants, or representatives.
- e) In the case of entrants and drivers in events, have agreed in the circumstances (aforesaid 1 d.) to exonerate and keep indemnified all and any other competitors, their servants, and agents, from and against any liability whatsoever, including direct liability, to such entrants or drivers in connection with the driving of karts or any other act, omission, of occurrence during the course of a competition or official practice.
- f) Have agreed as set out in this Regulation with each and all the persons and bodies referred to in those Regulations and so that each and any of those persons or bodies shall be entitled to the benefit of such agreements.

2. ACKNOWLEDGEMENT OF THESE REGULATIONS

- a) Every driver, entrant, official, promoter, organizer, or other participant in an SKC sanctioned event, and every person who is issued a SKC license agree, without reservation, to conduct themselves in accordance with these Regulations.
- b) In case of a disagreement or dispute regarding the meaning of application of these Regulations, the interpretation and application by SKC officials present at an event shall prevail.
- c) In order to promote the sport of kart racing and to achieve prompt finality in competition results, all SKC members and license holders expressly agree that decisions by officials as to the applicability and interpretation of these Regulations are not subject to litigation.
- d) SKC members and license holders covenant that they will not initiate or maintain litigation of any kind against SKC or anyone acting on behalf of SKC, with the intention of reversing, modifying, or obtaining relief from such decisions.
- e) If a member or license holder initiates or maintains litigation in violation of this covenant, the member or license holder agrees to reimburse SKC for all the costs of such litigation, including attorney's fees.

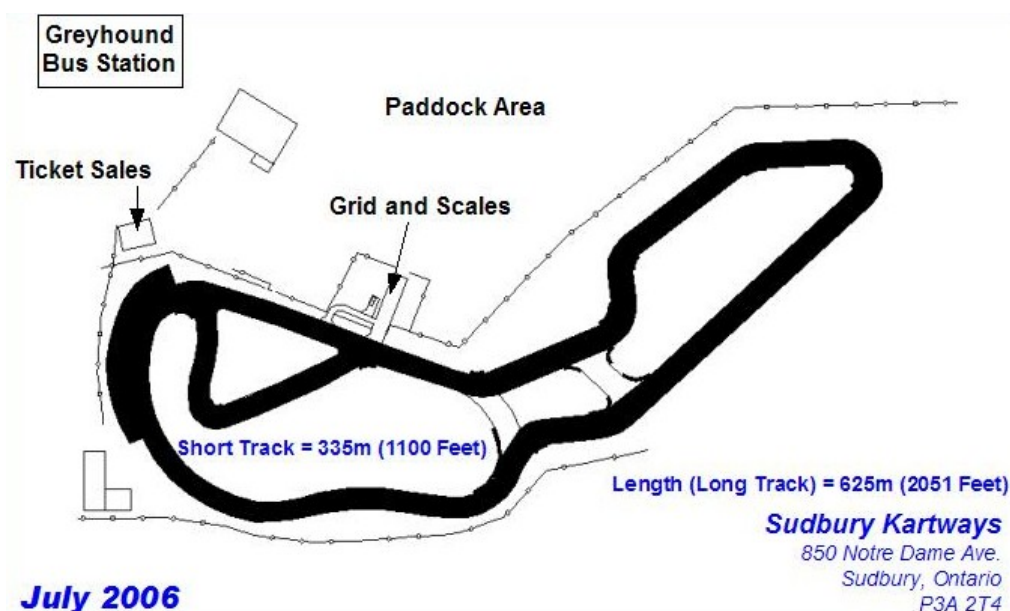

7. PRECEDENCE OF REGULATIONS

The event will be run in accordance with:

- a) GDS ASN Canada Canadian Karting Regulations Book 1, Sporting Regulations;
- b) GDS ASN Canada Canadian Karting Regulations Book 2, Technical Regulations;
- c) Rotax Max Challenge Technical Regulations
- d) Canadian Karting Regulations Briggs and Stratton Racing Class LO206 Canadian Engine
- e) ASN Bulletins issued and published prior to the event;
- f) Sudbury Kart Club Supplementary Regulations;
- g) Sudbury Kart Club Bulletins;
- h) Event Supplementary Regulations; and
- i) Instructions from Officials (including instructions provided at drivers briefing and from Marshals).

8. SKC BULLETINS

SKC Sporting and Technical Bulletins become effective on the date published. Bulletins published on the SKC or ASN website (<https://www.asncanada.ca/>) are deemed to be the official notification to all members.

9. ELIGIBLE ENTRIES AND LICENSE REQUIREMENTS

Rookies and second year Cadet drivers must attend the annual Driver Training. Drivers unable to attend the annual driver training must arrange individual instruction by the Race Director or designate before being allowed to compete. Track time must be arranged and paid by the driver requiring instruction.

Individual instruction is a privilege, not a right and will be provided at the Race Director's discretion.

Drivers must be viewed, judged, and approved to compete by the race director in consultation with other officials. A guideline of 110% of the average class time, the driver's demonstration of safe driving practice and knowledge of competition rules will be used to determine the competitor's fitness to compete.

Rookies must start at the back of the grid for their first three race events (ASN Sporting Regulations Section 2.1(d)). Drivers moving up a class are not required to start at the back of the grid.

Kart numbers will be assigned by the Board based on membership applications. Preference for kart numbers will be given to the previous year competitors. No letters will be assigned.

10. MEDICAL REQUIREMENTS FOR A DRIVER COMPETITION LICENCE

All License applicants are required to submit a medical form as prescribed in the ASN Sporting Regulations.

Any license holder who suffers injury or illness, at any time, that may impair or prejudice in any way the license holder's ability to drive a kart in speed events must report such injury or illness immediately to the SKC and must be re-certified by a medical practitioner as fit for competition before again competing, if requested by the SKC Board.

11. CLASSES

Drivers under 30 may compete in the Masters class with board permission only.

In accordance with the ASN Sporting Regulations (Section 9.4), the Race Director reserves the right to split a class at any number of competitors if safety becomes an issue.

Should a class be split, the following rules will apply for all drivers:

- i) **Qualifying:** Drivers shall qualify as per Section 17 of these Supplemental Regulations.
- ii) **Racing Heats:** Drivers will be divided into two groups (A and B) based on their qualifying time. A predetermined number of drivers will compete in the first group (A) and the remaining drivers will compete in the second group (B).
- iii) **Final:** Prior to the start of the final, the two highest placing drivers in the second group (B) shall move up into the final two positions of the first group (A) for the final race.
- iv) **Points:** Drivers in the first group (A) will be allocated points according to the points table outlined in Section 12 of these regulations. The drivers in the second group (B) will be allocated points based on the table in Section 12, with the exception; the highest placing driver's points will correspond to a finishing position behind the final position in first group (A). For example, ten drivers in the final for the first group would permit, the highest points total for the first-place driver in the second group (B) to be equivalent to 11th place or 20 points, with points for lower finishing drivers in Group B allocated according to Section 12.

12. PENALTY POINTS

Penalty Points (PPT) can be issued at standalone Events and at Club or Series Championships consisting of multiple races.

Drivers reaching a pre-defined number of Penalty Points will be issued additional penalties as defined in the Event, Club or Series Supplementary Regulations.

For Club or Series Championships, the Penalty Points would be totaled after each event. If a driver reaches the pre-determined total that triggers an additional penalty, the additional penalty would be applied at the next event the driver enters.

Additional penalties can include monetary fines, grid/position penalties, loss of championship points, disqualification from an event, suspension (including race bans), exclusion from any type of participation, withdrawal of license and probation.

Penalty Points issued to a driver at an event shall be noted on the Official Results e.g., 5 PPT. (See Book 1, 11.6. Penalty Points for the PPT Chart.)

13. CHAMPIONSHIP POINTS

Only SKC members will be eligible to accumulate championship points.

Master's drivers will be awarded points for both Master's and Senior classes. To qualify for Master's points, drivers must register for the Master's class.

Calculation of championship points will be based on the competitor's total points for all SKC events less **two races (two race drop)**. Competitors may not drop a race result in which they

have been **disqualified**.

All final point totals that result in a tie will be broken by determining the competitor with the greatest number of first places finishes in SKC events. Failing this, the competitor with the greatest number of second place finishes in SKC events will be declared the winner of the tie breaker, and so on.

Drivers will be awarded championship points for the final, pre-final and qualifying. Points will be awarded according to the Sudbury Kart Club championship point tables.

In the event hand scoring is used for the entire event, the following applies:

- Drivers will be awarded championship points for the heat 1, heat 2 and final.
- Points will be awarded according to the Sudbury Kart Club heat and final point tables. Heat 1 will be awarded heat points; Heat 2 will be awarded heat points and the final will be awarded final points.

Karts that start but do not finish (DNF) receive championship points according to their laps completed. If two or more karts complete the same number of laps, points will be awarded based on the karts position from the last completed lap.

16. ENTRY FEES

Entry fees are \$90 for Sudbury Kart Club members and visitors. Visiting competitors must be licensed by an CASC-OR GDS Canada affiliated Kart Club. A 50% discount will be applied for additional entries for the same driver.

17. LATE ENTRIES

Entries for an event shall not be accepted after the close of registration as listed on the Official Schedule. A late entry can only be accepted by special permission of the Race Director. A late registration fee of \$20.00 will be applied if a late entry is accepted. If any entry has missed or is

late for the Driver's Briefing an additional fine of \$10.00 will be issued. A late entry can be refused for any reason. Refusal to accept a late entry is not subject to protest or appeal. A late arrival at or missed Driver's Briefing will result in back grid position. Failure of a driver to attend a mandatory Driver's Briefing will waive the competitor's right of protest for that event.

18. REGISTRATION

Entrants may register at the track (at the official's table in the scale area) the morning of each event beginning at 7:15AM until 7:45AM. Pre-registration will be accepted at the discretion of the SKC Secretary.

19. TECHNICAL INSPECTION

All drivers must present a completed pre-race Self-Technical Inspection form to the Registrar prior to official practice. Once the Registrar has received the form, an approved marking may be issued to the driver, which must be displayed on the kart to be allowed on the track.

Rookie drivers may be requested to present their Self-Technical Inspection form as well as their kart and safety equipment to the Technical Inspectors 30 minutes prior to official practice, for the first two races.

Tires and engines will be marked and sealed per ASN regulations after the first Qualifying Session for all karts in all classes. It is the driver's responsibility to make sure that the tires and engine have been marked and sealed after the first Qualifying Session. Breaking of marks or seals for race day repairs must be completed with the approval of and under direction of a technical inspector. Remarking and resealing is the driver's responsibility.

After the top three finishing karts are weighed, the drivers will put their kart in the technical inspection area.

Any karts may be inspected in each class following the final. Only the Technical Inspectors will release karts from the technical inspection area. If there are any infractions, the technical personal will report the driver to the Race Director and the appropriate penalty will be applied. It is the driver's responsibility to make sure that all marks and seals are unbroken.

Access to the scale and the entry to the scale are restricted to officials and drivers, only when their class has completed racing.

20. QUALIFYING PROCEDURE

Events will be scored by computer timing and/or hand scoring.

Qualifying using computer timing determines the starting positions in the Pre-Final. The results of the Pre-Final determine the Final starting order.

In the event hand scoring is used for the entire event, the following applies:

- A random draw by the driver only, will determine the starting position in qualifying Heat 1. The qualifying Heat 2 starting order is the reverse order of qualifying heat 1.
- The qualifying points accumulated in the qualifying heats will determine the starting order for the final. Qualifying points will be awarded according to the Sudbury Kart Club heat points table for each qualifying heat. Total qualifying points will be calculated from the qualifying heat points for qualifying Heat 1 plus qualifying Heat 2. The driver with the greatest total qualifying points will start in the pole position for the final. All ties will be awarded to the driver with the better initial draw position.
- Qualifying Heat 1 and 2 distances (laps) will be announced at the drivers meeting.

The Race Director reserves the right to split qualifying at any number of competitors if safety becomes an issue.

Seniors and Masters will qualify together. The Pre-Final and Final order will be the Senior Class order. Junior and Junior Light will qualify together.

21. OFFICIAL NOTICE BOARD

The Official Notice Board is located outside the pre-grid area.

22. DESIGNATED FUEL STATION

The Esso Fuel Station at 180 Lasalle Blvd. is the designated fuel location for all Sudbury Kart Club events at Sudbury Kartways. The spec fuel for all Sudbury Kart Club events and classes will be Esso Extra 91 Octane.

23. REGULATIONS THAT MUST BE SPECIFIED IN THE SUPPLEMENTARY REGULATIONS TO APPLY:

Maximum overall width for all Four-Cycle classes including: Junior, Senior and Masters will be 127cm (50")

- Gear Ratio:** 17 tooth clutch sprocket and 59 tooth axle sprocket (3.47 ratio) or 19 tooth clutch sprocket & 66 tooth axle sprocket (3.47 ratio).
- Tires:** Vega Blue, 10x4.50-5 front and 10x4.50-5 rear
- Weight:** 235 Lbs. Minimum

Junior Light Class

- Engine:** Briggs and Stratton LO206 with blue carburetor slide, carburetor lock.
- Tires:** Vega Blue, 10x4.50-5 front and 11x6.00-5 rear
- Weight:** 265 Lbs. Minimum
